Norfolk Southern – Vanessa Nedrick presented the Board with a Cost Estimate for the Norfolk Southern Wastewater Treatment System Upgrades and Engineering Cost.

H2O Grant for Public Sewer on Old Bristol Pike - Vanessa Nedrick reported that she and Martin Witt met with Morrisville Boro on May 24, 2012. At the meeting Morrisville indicated they did have capacity for the sewage.

Vanessa Nedrick indicated she would have more to report next month.

<u>2011 Inflow & Infiltration Program</u> – Vanessa Nedrick reported the additional work that was approved should be completed by next month.

<u>Bucks County Water & Surcharge Billing</u> – Vanessa Nedrick reported that she reviewed the documentation that was requested from Bucks County Water and Sewer and feel there are some discrepancies.

Vanessa Nedrick has requested a meeting with Bucks County Water and Sewer at the sampling site to go over the sampling.

Vanessa Nedrick would also like the Authority to have an independent lab also test at the same location that Bucks County Water & Sewer is testing.

Headley Pump Station – Vanessa Nedrick reported her and Marty Witt met with the Authority's independent lab on June 19th and took the first samples, one at the wet well and the other at Siemens discharge manhole. This will be done twice a month.

<u>Fallsington Water Investigation</u> Vanessa Nedrick present to the Board three options for a water main replacement in Old Fallsington.

The Board made a motion to accept option three with an estimated cost of \$1,794,170.00 and directing Remington Vernick and Beach to proceed with the preparation of design plans and specifications for the proposed project.
