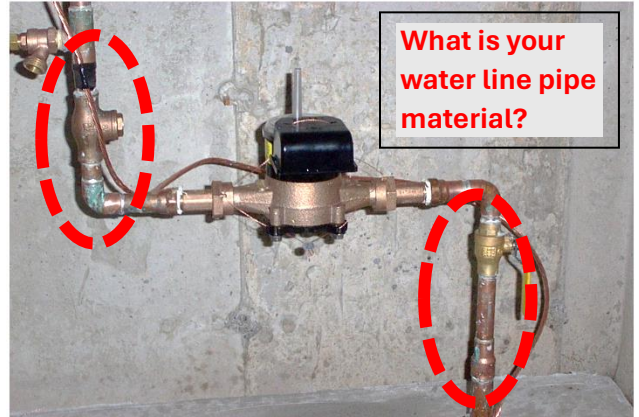




## **Important Water Line Survey**

The Township of Falls Authority is following US Environmental Protection Agency requirements to create an inventory of lead service lines in our water service area.

**Without your cooperation in the mandatory survey, the Authority may need to engage consulting firms to obtain the required information for the EPA. This cost will impact future rates to the ratepayer. Please help us control this cost.**



Your service line is the pipe that connects the water main to your home or business. This pipe brings water inside the home/business and is owned by the property owner. It brings water to your meter, usually in the basement. We need your help to identify the service line material at your house.

We also need to know what your interior plumbing is made of, that is the pipe after the meter. Here are some pictures of what the different pipes look like. If you are not certain what kind of pipe you have, or have a meter picture like the above, please take a picture of it & email it to the Authority at [info@tofa-pa.com](mailto:info@tofa-pa.com). **Please include your address with the pictures on the email.**

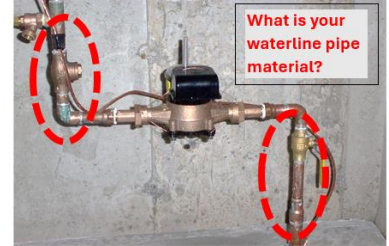


GALVANIZED STEEL
